## **SCHOLARSHIP COMMITTEE**

The deadline, May 30th, for receiving student applications for the upcoming two educational grants has now passed and the Scholarship Committee is beginning its review process. The grants are for \$2000 each and cover academic year 2015-2016. To be eligible, students must be at least 21 years old, hold a high school diploma or equivalent, be pursuing an Associate or Bachelor degree from an accredited college or university, and reside in a town covered by our Branch. Recipients will be chosen on the basis of personal goals, academic performance, and financial need. Awards will be announced by July 1st. Both recipients will be invited to a Branch meeting in September, allowing everyone an opportunity to meet them.

NCCWSL was held at the University of Maryland at the end of May with about 1000 students

attending. There were nearly 50 students from CT who attended, including Briana P. and Amanda M. both of whom our Branch sponsored. Feedback is expected from each of them shortly and, in addition, they have been invited to speak with us at a Branch meeting in October.

Treasurer's Report Dot B. reported the following

The savings account covers grants, AAUW Fund contributions, and past general savings.
