The meeting was held at Acton Library and was called to order by President Deb DeHertogh at 1:06 pm.

Approval of Minutes for August 29th meeting

A motion was made by Kathy Heebner, seconded by Mary Jane Peterson to approve the board minutes of August 29, 2022 as presented. The motion passed unanimously.

Treasurer's Report

People's Bank has been bought out by M & T Bank. AAUW as a business account will have several costs associated with this change. Mary Ann ladarola noted that deposit slips and a stamp for checks would need to be purchased.

August treasurer's report reviewed. Beginning balance in Business Advantage Checking: \$8,918.65. Ending Balance \$5,898.76. A donation was made in honor of Penny Hein which will be included in the Recognition Fund. Outstanding expenses: \$90. One new member was paid for with the debit card. Full dues (\$98) were charged and local dues (\$21) are expected to be refunded to LCV. Mary Ann will follow-up next month.

The Treasurer's Report will be filed for audit.

A question was raised regarding the Bequest Fund which has \$15,000 "unavailable for use". This will be discussed/clarified at our next meeting.

Programs for year and purchase of new projector/screen

Gloria Gery and Lucy Duddy discussed the End-of-Year Social to be held at the Elks Club on 6/15/23. This is to be a cocktail party with passed hors-d'oeuvres. \$35/person with guests welcome. A \$500 deposit is needed. The event can be canceled 3 months prior or the date shifted with no penalty.

Membership

Margie Rice distributed the new, GORGEOUS membership directories. The gold paper with color printing on the front is perfect for our 50th anniversary! The price did increase this year (\$267 for 100 booklets vs \$148 for 120 booklets last year.) Margie did look at alternative printers but found that others (such as Staples) would have been \$1 more per booklet.

We currently have 81 members. 17 members did not renew, reasons ranged from moving, health reasons, to politics (National). We have 12 new members and therefore doing well compared to many other locals. We have 3 Shape the Future free memberships.
