The meeting was held at Acton Library and was called to order by President Deb DeHertogh at 1:00 pm.

**Approval of Minutes for June 27<sup>th</sup> meeting**

Correction made to indicate that National AAUW does not recommend a change to 501c3 status, not CT-AAUW.

Also, we planned to donate \$260 to National AAUW in '21-22 but the donation did not occur until after the fiscal year since National was not ready to accept the donation.

A motion was made by Sue Aberbach, seconded by Linda Frigon to approve the board minutes of June 27, 2022 with corrections. The motion passed unanimously.

**Treasurer's Report**

May, June and July treasurer's reports reviewed by Mary Ann Iadarola.

Clarification for May was a formatting issue for 5/16/22 that didn't show full explanation.

June report shows Fiscal YTD Interest (\$41.03). Year-to-date will be reflected in all future reports.

July report reviewed. Beginning balance in Business Advantage Checking: \$7,781.61. Ending Balance \$8,918.65. Barbara Spargo has increased her monthly donation to \$225 for the NCCWSL Scholarship. Outstanding expenses: \$3,195 which include grants to 3 students.

The Treasurer's Report will be filed for audit.

Thank-you letters were received from Acton Library for donations of \$100 and \$175.

Mary Jane Peterson and Linda Frigon met with Mary Ann for an Audit on July 29, 2022. They reviewed the books and found all in order.

**Change in Meeting Dates for 2023**

Meeting dates for March - June have been changed to Thursday due to the Pavillion being booked for Wednesdays during that time.

## **Fundraising**

A flier for the Book Author Luncheon was distributed. More people needed to help with this event. Committee is looking at the cost and what to charge to attend.

Linda gave an update on 501(c)3 status. LCV is considering applying for a change of status from our current 501(c)4 to 501(c)3. Although National discouraged us from pursuing the change several years ago due to time and resources required, it is believed that pursuing larger donations to support our scholarship goals without a change in status seems impractical. Linda spoke to the Meriden Branch treasurer and two board members with experience with 501c3. Bookkeeping requirements (annual report) seem manageable although an attorney or CPA may be desirable to set-up -- does anyone know anyone who can help?. Donations would be tax-deductible and matching grants can be applied for with this status. Next steps: Linda will look at the application process.

## **Scholarship**

Sue and others from the Scholarship Committee met with the 3 grant recipients at Penny Lane Pub. All three expressed interest in attending our January meeting.

The Committee will meet in October. Plans to review the application and hope to make it interactive on the website. Also plan to look at publicity, sending a picture of grant recipients out to the press.

## **Membership**

We currently have 67 members that have paid their 2022-23 membership dues. (We had 86 members in September 2021 in our last directory.) Dues must be paid by our September 7th meeting for members names to be in our 2022-23 membership directory. The new directories will be finished soon after our September meeting and then printed. They will be available for distribution at our October meeting.

We have been encouraging members to renew by check because many people have had problems using National's new website. I have sent detailed instructions to members that would like to pay by credit card using the new website. The new site no longer sends members a direct link to renew.

We have 7 members not renewing. We are waiting for 21 to renew. Deb Herskowitz is making phone calls to these members.

We have 5 new members through the Shape the Future Program (they received 50% off national dues). We will have 2 free National Memberships available this year through this program.

Discussed publicizing LCV-AAUW in local newspapers to attract new members,

\$64 of national AAUW dues is tax-deductible; this amount to be put into membership booklet.
