The meeting was held at Acton Library and was called to order by President Deb DeHertogh at 1:03 pm.

Approval of Minutes for May 1, 2023

A motion was made by Gloria Gery, seconded by Margie Rice to approve the board minutes of May 1, 2023 as presented. The motion passed unanimously.

Treasurer's Report

MaryAnn ladarola shared the Treasurer's Report from May 31, 2023. Beginning balance \$13,035.91, ending balance of \$13,104.92.

Combined Bequest and Business Savings: beginning balance \$20,907.47 and ending balance of \$20,911.25.

Question raised as to wording related to Bequest Fund and suggested to be changed to "unavailable for operating expenses unless specifically approved by LCV Board" as this reflects wording in the by-laws. Report will be filed for audit.

Update on 501(c)(3) -- Linda Frigon

We can open a bank account in the next few weeks. Linda provided an accounting of monies to be moved from AAUW-LCV to the AAUW-LCV Education and Scholarship Program, Inc. (501(c)(3)). The total amount to be transferred is \$13,232.78. Once an additional \$1,500, promised from a sponsor once our 501(c)(3) is established, the total will be \$14,732.78.

Membership -- Margie Rice and Deb Herskowitz

- ➤ We currently have 95 members
- > 10 members have joined since the BAL
- Members should be renewing this month and tracking is challenging since AAUW has gone to rolling renewals
- > LCV has 2 lifetime members who pay only local dues.
- > One member is a student member from the New Haven area
- ➤ We have 2 more free National memberships through Shape the Future
- > The application form has been modified to include a date so that current dues are reflected
- A new member social will be held in the fall to welcome and introduce members to AAUW-LCV

Scholarship -- Sue Aberbach

- ➤ 10 applications for the Educational Grants. Criteria: Career and Personal Goals, Need and Academic Achievement. 6 women have been selected to receive grants. The Scholarship Committee recommended five of them to receive \$1000/semester for the year: Aleia Hayes, Talia Hincks, Taylor Roy, Tajeah Winston, and Jessica Wood. One woman recommended to receive \$1000 for just one semester since she will be graduating: Jessica Sponheimer.
- Personal networking seems to be crucial to getting the word out about these educational grants.
- ➤ Motion by Mary Jane Peterson, seconded by Jeannette Santovasi, to fund the \$11,000 for the 5 ½ Educational Grants recommended by the Scholarship Committee. Motion passed unanimously. Note that these monies could come from the Education and Scholarship Program if the bank account has been established by the time money is needed.
- ➤ The first check to these women will be presented to them at a luncheon held later this summer. Photos from that luncheon will be used in press releases.

LCV Social Media: Gloria Gery

Our website now has an interactive calendar for all LCV events. Addresses and Zoom invites can be linked on the calendar. Documents (such as agendas) can't be uploaded into the calendar but such information can be put into the Notes section.

Working to have a password-protected Member-Only page on our website to include Membership Roster and contact list. Still working through what should be there (Minutes, Treasurer's Reports, etc) and how to store it. Goal to have this done and implemented by September 2023.

Privacy Policy - the group reviewed the proposed Privacy Policy. A motion was made by Lucy Duddy to adopt the Privacy Policy as presented. See attached. This motion was seconded by MaryAnn ladarola. The motion passed with one nay vote. Gloria will make corrections to the

form to be signed by members to reflect the adopted policy. Lucy offered to facilitate the collection of forms by all members.

Programs -- Gloria Gery & Lucy Duddy

Programs for the year are being planned, several have been recommended by members including Sustainability, Rise of Anti-semitism, Artificial Intelligence, Egyptology and others. We need a projector for our meetings that is capable of working when there is ambient light in the room. Jeannette reported that OS Park & Rec has a projector and she plans to borrow it to check it out.
