Lower Connecticut Valley AAUW Branch Meeting October 12, 2023

Members Present: There were over 35 members and several new members and guests present at the meeting held at Saybrook Point Pavilion. The meeting began at 7 pm when Carole Otto introduced our speaker.

Program: Carole introduced her son, Evan Bernstein, our guest speaker for the evening. Evan has over 25 years of non-profit work experience. He is currently the National Director of the Community Sercurity Service (CSS). He began his career working for the United Way of NYC and then AIPAC, American Israel Public Affairs Committee. He earned a master's degree in nonprofit management. He has served as vice-president of the northeast division of the Anti-Defamation League, ADL. Evan has been quoted in sources such as CNN, ABC, the Wall Street Journal, and Fox News. He cofounded the NYC Interfaith Security Council in 2021 and has been listed as a person in the top 100 people who positively influence Jewish life globally.

Evan's topic, The Rise of Anti-Semitism in a Partisan Political Environment, held everyone's attention. Evan spoke about the rise of antisemitism over the last decade in America. He talked a bit about various incidents of hate that he was at and reported on. Of religiously-motivated hate crimes, 60% in the U.S. are against Jews although Jews make up only roughly 2% of the population. He spoke about security and the need for it at Jewish buildings, synagogues, Jewish community centers, etc. and the need for the layperson to keep an eye out for anything that might look different. He spoke about how for hundreds of years Jews have been treated badly and discriminated against and he feels that the way to stop this hate is for interfaith activities. He feels if people learn about each other from different factions that they would all understand that people are more alike than they are different. He emphasized that we all should be willing to say something if inappropriate comments are made.

Gloria Gery, Program Coordinator, thanked Evan for his time.

After a break, the business meeting was conducted by Jeannette Santovasi, vice-president. 28 members remained after the program. New members were welcomed and introduced themselves.

Treasurer's Report: MaryAnn ladarola reviewed the September report. Beginning balance in Business Advantage Checking: \$1,883.22. Ending Balance \$1,676.24. A majority of income and expenses were due to membership. The ending balance of the Business Money Market account was \$20,939.40 with \$66.44 in interest earned. MaryAnn pointed out that our interest rate has increased dramatically and that due to the recent dues increase combined with the number of members we have, we are expected to have enough money to cover our budgeted expenses.

IRA Contributions to Scholarship Program: Sue Aberbach provided information, from Linda Frigon, regarding 3 ways to contribute to the AAUW-LCV Scholarship program. You can donate directly from your IRA's Required Minimum Distribution (RMD) and have the full amount of your qualified contribution taken "off the top" of your taxable income. It's a very tax-efficient way to give – and more valuable than taking a taxable IRA distribution. This must be done through your financial advisor or investment company. Linda can provide them with the tax ID, or any other information their advisor or investment company may need. Donations may also be made directly by writing a check or by using the donate button on the LCV website. This information will be made available in the next newsletter as well.
