AAUW-LCV ESP Board Meeting November 6, 2023

The meeting was held at Acton Library and was called to order at 1:01 pm.

Approval of Minutes for October 2, 2023

A motion was made by Linda Frigon, seconded by Mary Jane Peterson to approve the board minutes as presented. The motion passed.

Treasurer's Report -- Linda Frigon

Linda reviewed the budget for FY 23-24. Income was given as \$8,457.78 with expenses at \$7,449. A question was raised regarding including projected income from fundraising, in particular the Book Author Luncheon.

The October 31st Treasurer's Report was reviewed. Beginning checking balance \$1,139.78 and ending balance \$1,064.83. Expenses were for Zoom. Savings balance began at \$6,110.60 and ended at \$8.632.50. Recognition Fund transfer from LCV of \$383.63 was deposited. The donation expected once we obtained 501c3 status was received and was higher than expected (\$2000 rather than the \$1500 promised.) Linda questioned M&T regarding the service charge for a non-profit and these charges were reversed (\$12.50). It is possible this was a courtesy and may not continue. Since the savings account earns 4.5% interest, all deposits will be put into that account and money transferred as needed to the checking account. Report to be filed for audit.

Zoom - Linda Frigon

The use of one Zoom account means that users would need to have their device verified via the ESP email. Anyone who uses a Zoom account for AAUW business can obtain a subscription for \$79.

Donation Button on LCV website -- Linda Frigon

The donation buttons are active, one to donate directly to the 501(c)(3) Scholarship Program, the other to AAUW National. Board members have tested them out and they seem to work well although there are extra buttons that Gloria will seek to have removed.. The donation buttons will be discussed at the next branch meeting.

Fundraiser, Book Author Luncheon -- Linda Frigon and Penny Hein

Linda shared that the amount that goes to scholarships should be shared with people who purchase tickets. She presented information on the fees and costs for the BAL. Including all fees and taxes and dividing among 140 guests, the total per person came out to \$64.18. Barb Dimberg made a motion to set ticket prices at \$75 and to keep patron tickets at \$125. Motion seconded by MaryAnn ladarola. The motion passed unanimously.

Scholarship - Sue Aberbach & Olga Saubermann

The Scholarship Committee met in October and discussed the application questions -- changing the wording of questions so that a fuller picture of the candidate is obtained and whether the FAFSA will be considered as part of the process. In addition, Jessica Sponheimer is to be given a full grant. Her program ends in December. Next meeting November 29th.

Mary Jane Peterson reported that the state AAUW scholarship is up in the air. This is due to the absence of a President for the State of CT AAUW following the retirement of Nana Amos and illness of other members.
