The meeting was held at Acton Library and was called to order by President Deb DeHertogh at 1:54 pm.

Approval of Minutes for October 2, 2023

A motion was made by MaryAnn ladarola, seconded by Gloria Gery to approve the board minutes as presented. The motion passed unanimously.

Treasurer's Report -- MaryAnn ladarola

The Treasurer's Report for October was presented. Beginning balance \$1676.24 ending balance of \$1604.91. Deposits were for member renewals or Great Decisions. Expenses: member renewals plus \$388.70 to Ciel copy center for 130 booklets; \$150 to AAUW National for American Fellowship Fund; \$500 for Elks Club deposit for June gathering; \$383.63 balance of Recognition Fund transferred to ESP; \$200 AT Insurance.

Combined Bequest and Business Savings: beginning balance \$20,939.40and ending balance of \$21,013.96.

Budget vs. Actual -- Rentals is at \$675 but \$500 is a deposit for Elks Club and will be refunded. The report will be filed for audit.

November & December branch meetings -- Deb DeHertogh

Our annual collection for Safe Futures Women's Shelter will be done at the November meeting. Donations of clothing or gift cards accepted. Gloria and Jeannette will help with collections and transporting donations. Safe Futures will be discussed at the branch meeting to let members know of its purpose and why we support them.

Deb, Mary Jane Peterson and Jeannette Santovasi will reach out to Park and Recs regarding a screen for the Pavillion.

Board agreed that rather than have everyone bring food to the Holiday Party on December 14th, the Hospitality Committee will ask for 10 volunteers to bring goodies. They will provide punch, cider and water. It was agreed that the money collected for the White Elephant/Raffle would be donated to AAUW-National.

A discussion was held regarding the End-of-Year Social. The room we used last year can hold 50 people but is tight with tables and food. The Elks have told Gloria that if we have more we can overflow into the banquet room. The cost for the event is \$35 and some suggested that \$40 be charged with extra money going to AAUW-National. The board agreed that instead the price should remain \$35 and that a 50/50 Raffle be held instead to raise money for National.
